DESCRIPTION OF 0.586 ACRE PARCEL

Situated in the State of Ohio, County of Richland, Township of Jackson, lying in the Northwest Quarter of Section Twenty Seven (27), Township Twenty Two (22), Range Nineteen (19), of an original tract conveyed to B.N. West by deed of record in Official Record Volume 2535, Page 27 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at an iron pipe found at the Northwest corner of the Northwest Quarter of said Section 27 at the intersection of Myers Road (C.H. 201) and Rock Road (C.H. 150);

thence South 00°02'30" East, with the West line of the Northwest Quarter of said Section 27 and the centerline of said Rock Road, a distance of 1008.72 feet to the Southwest corner of a 15.0 acre tract conveyed to J.E. & L.L. Adkins by deed of record in Official Record Volume 2995, Page 3798, said point being the POINT OF BEGINNING for the tract herein described, referenced by an iron pipe found, North 89°55'14" East, a distance of 20.66 feet;

thence North 89°55'14" East, with the South line of said 15.0 acre tract, a distance of 225.80 feet to an iron pipe found at the Northwest corner of a tract conveyed to Z.J. & M.M. Tuttle by deed of record in Official Record Volume 3012, Page 5277;

thence South 00°07'47" East, with the West line of said Z.J. & M.M. Tuttle tract, a distance of 113.00 feet to an iron pin set at the Northeast corner of a 0.57 acre tract conveyed to C. Noble by deed of record in Official Record Volume 2712, Page 677;

thence South 89°55'14" West, with the North line of said 0.57 acre tract, a distance of 225.98 feet to a railroad spike set on the West line of the Northwest Quarter of said Section 27 on the centerline of said Rock Road, passing by a 5/8" rebar found at a distance of 204.91 feet;

thence North 00°02'30" West, with the West line of the Northwest Quarter of said Section 27 and the centerline of said Rock Road, a distance of 113.00 feet to the POINT OF BEGINNING, passing by a railroad spike found at a distance of 112.83 feet, containing 0.586 total acres of land, more or less;

Subject, however, to all legal rights-of-ways and/or easements of record.

Iron pins set, where indicated, are iron rebar, five/eights (5/8) inch diameter, thirty (30) inches long with a plastic cap on top stamped "HANNING PS 8568".

The bearings herein are based on Richland County Engineer Survey QQ-124.
