DESCRIPTION OF 0.356 ACRE PARCEL

Situated in the State of Ohio, County of Richland, City of Ontario, lying in the Northwest Quarter of Section Thirteen (13), Township Twenty One (21), Range Nineteen (19), of an original tract conveyed to 204 N Seltzer, LLC by deed of record in Official Record Volume 2960, Page 3 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at a monument box found at the intersection of Lexington-Springmill Road (C.H. 133), being the West line of said Northwest Quarter and Ferguson Road (T.H. 202);

thence North 00°55'26" East, with the centerline of said Lexington-Springmill Road and the West line of said Northwest Quarter, a distance of 46.89 feet to a point projected from the North right-of-way line of said Ferguson Road, referenced by an iron pin set, South 89°37'11" East, a distance of 65.24 feet;

thence South 89°37'11" East, with the North line of said Ferguson Road, a distance of 391.73 feet to a capped "Richland Eng, PLS 4939" iron pin found at the Southeast corner of a 0.356 acre tract conveyed to Lin-Rose, Inc. by deed of record in Official Record Volume 367, Page 216, said point being the POINT OF BEGINNING for the tract herein described;

thence North 00°56'49" East, with the East line of said 0.356 acre tract, a distance of 155.00 feet to a 5/8" rebar found on the South line of a 18.612 acre tract conveyed to Sam's Real Estate Business Trust by deed of record in Official Record Volume 1338, Page 524;

thence South 89°37'11" East, with the South line of said 18.612 acre tract, a distance of 100.00 feet to an iron pin set at the Northwest corner of a 0.36 acre tract conveyed to J.L. Henry by deed of record in Official Record Volume 2918, Page 378;

thence South 00°56'49" West, with the West line of said 0.36 acre tract, a distance of 155.00 feet to an iron pin set on the North line of said Ferguson Road;

thence North 89°37'11" West, with the North right-of-way line of said Ferguson Road, a distance of 100.00 feet to the POINT OF BEGINNING, containing 0.356 total acres of land, more or less;

Subject, however, to all legal rights-of-ways and/or easements of record.

Iron pins set, where indicated, are iron rebar, five/eights (5/8) inch diameter, thirty (30) inches long with a plastic cap on top stamped "HANNING PS 8568".

The bearings herein are based on Ferguson Road Right-of-Way Plans dated January 20, 2015.
