## **LEGAL DESCRIPTION**

## PART NE 1/4 SECTION 25 T-20 N, R-19 W TROY TOWNSHIP RICHLAND COUNTY, OHIO

October 29, 2024

**Situated** in the Township of Troy, County of Richland, State of Ohio and being a part of the Northeast Quarter of Section 25, Township 20-North, Range 19-West, being a portion of the lands conveyed to Matthew D. Garber and Connie S. Garber, Trustees of the Garber Family Trust dated October 13, 2020 by official record volume 3017, page 1186, being more particularly described as follows:

**Commencing** at a Magnail spike found and accepted as marking the intersection of Mill Run Road (T.H. 130)(R/W Varies) and Kochheiser Road (T.R. 325)(60' R/W);

Thence, North 27 degrees 45 minutes 00 seconds East, 351.79 feet along the centerline of said Mill Run Road to a 2" Magnail spike set, being the Place of Beginning of the parcel herein described:

Thence, the following **TEN** courses:

- 1. North 27 degrees 45 minutes 00 seconds East, 431.52 feet along said centerline of Mill Run Road to a railroad spike found, being a southwest corner of a parcel conveyed to William Kylor Walker by official record volume 2555, page 388;
- 2. South 58 degrees 57 minutes 36 seconds East, 34.24 feet along a south line of said Walker parcel to an iron pin found;
- 3. North 31 degrees 55 minutes 59 seconds East, 197.86 feet along an east line of said Walker parcel to an iron pin found;
- 4. North 84 degrees 32 minutes 37 seconds East, 270.53 feet along a south line of said Walker parcel to an iron pin found;
- 5. North 61 degrees 57 minutes 48 seconds East, 105.06 feet along a southerly line of said Walker parcel to an iron pin found;
- 6. North 23 degree 25 minutes 07 seconds West, 118.60 feet along an east line of said Walker parcel to an iron pin found, also being in the southeast corner of a parcel conveyed to William Kylor Walker by official record volume 3001, page 3586;

- 7. North 28 degrees 23 minutes 38 seconds West, 197.89 feet along the east line of said Walker parcel to an iron pin found, in the northeast corner thereof;
- 8. **North 72 degrees 27 minutes 33 seconds East, 25.72 feet** traversing aforementioned Garber lands to an iron pin set on the west existing right of way line of the Richland County B & O Bikeway (100' R/W) as conveyed to the Board of Park Commissioners by deed volume 907, page 624;
- 9. **South 28 degrees 24 minutes 27 seconds East, 942.13 feet** along said west existing right of way line of said B & O Bikeway, said Board of Park Commissioners parcel, to an iron pin set, also being the northeast corner of a parcel conveyed to Michael E. Miller and Diane E. Miller by official record volume 2998, page 410;
- 10. **South 86 degrees 08 minutes 54 seconds West, 1030.77 feet** along the north line of said Miller parcel, passing through an iron pin set for reference at 983.81 feet, to the **Place of Beginning**, containing 9.0292 acres, more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.

Bearings are based on an assumed meridian and are used to express angles only.

Iron pins set are 5/8" diameter rod with plastic cap stamped "Ramsey S-8396".
