DESCRIPTION OF 2.129 ACRE PARCEL

Situated in the State of Ohio, County of Richland, Township of Washington, lying in the Northwest Quarter of Section Twenty Nine (29), Township Twenty (20), Range Eighteen (18), of an original tract conveyed to A. & M.N. Christman by deed of record in Official Record Volume 2631, Page 715 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at an aluminum capped pin at the Southwest corner of the Northwest Quarter of said Section 29:

thence North 00°50'16" West, with the West line of the Northwest Quarter of said Section 29, a distance of 260.21 feet, said point being the POINT OF BEGINNING for the tract herein described, referenced by an iron pipe found, South 88°23'28" East, a distance of 30.31 feet;

thence continuing North 00°50'16" West, with the West line of the Northwest Quarter of said Section 29, a distance of 399.88 feet to an iron pin set at the Southwest corner of a 10.00 acre tract conveyed to D.L. & J.M. Isley by deed of record in Official Record Volume 2991, Page 5439;

thence South 89°27'18" East, with the South line of said 10.00 acre tract, a distance of 231.67 feet to an iron pin set at the Northwest corner of a 5.91 acre tract conveyed to J.R. Moore by deed of record in Official Record Volume 2465, Page 75;

thence South 00°34'45" East, with the West line of said 5.91 acre tract, a distance of 404.11 feet to an iron pipe found at the Northeast corner of a 1.06 acre tract conveyed to B.C. & H. Latore by deed of record in Official Record Volume 3017, Page 2980;

thence North 88°23'28" West, with the North line of said 1.06 acre tract, a distance of 229.98 feet to the POINT OF BEGINNING, containing 2.129 total acres of land, more or less;

Subject, however, to all legal rights-of-ways and/or easements of record.

Iron pins set, where indicated, are iron rebar, five/eights (5/8) inch diameter, thirty (30) inches long with a plastic cap on top stamped "HANNING PS 8568".

The bearings herein are based on Richland County Engineer Survey OO-58.
