



## DESCRIPTION LOT 2378, PART LOT 2377 AND PART SD 1 OFLOT 494

Situated in the State of Ohio, County of Richland, City of Shelby, being Lot 2378, part of Lot 2377 as indicated on Plat Volume 13, Page 8, and part of SD 1 of Lot 494 as indicated on Plat Volume 2-3, Page 11, of the consecutive numbered lots in said City, and being more particularly described as follows;

**BEGINNING** at a 1/2" iron pipe in concrete found marking the northeast corner of Lot 2378, said pipe being in the south right-of-way line of Raymond Avenue (60 feet in width);

Thence with the following Four (4) courses;

- 1. South 00°35'34" East, 161.45 feet with the east line of Lot 2378 and Lot 494 to a 5/8" rebar with cap stamped "Weigler 7747" set to replace a bent and leaning 1/2" iron pipe found;
- 2. South 88°38'12" West, 69.95 feet to a 1/2" iron pipe found;
- 3. North 00°35'34" West, 162.73 feet to a 1/2" iron pipe in concrete found in the south right-of-way of Raymond Avenue;
- 4. North 89°40'59" East, 69.94 feet with the south line of Raymond Avenue, containing 11,336.33 square feet, of which 4211.72 square feet are in Lot 2378, 2017.05 square feet are in Part Lot 2377 and 5107.56 square feet are in Part SD 1 of Lot 494, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on an assumed meridian, and are used to express angles only.
