**COMMENCING** at an existing railroad spike at the intersection of the centerline of Bloominggrove Road, Township Highway 46 (also being the South line of the Northwest quarter) with the centerline of Stevens Road, Township Highway 172;

Thence running North 02 deg. 52 min. 26 sec. West along the centerline of Stevens Road for 1376.29 feet to an existing railroad spike;

Thence turning and running North 04 deg. 00 min. 59 sec. East along said centerline for 396.00 feet to an existing railroad spike;

Thence turning and running North 02 deg. 39 min. 59 sec. East along said centerline for 156.78 feet to the **PLACE OF BEGINNING** (a 5/8 inch rebar set South 85 deg. 45 min. 08 sec. East and 20.80 feet from this point);

Thence continuing North 02 deg. 39 min. 59 sec. East along said centerline for 34.66 feet;

Thence turning and running South 89 deg. 24 min. 35 sec. East (passing an existing iron pin at 20.00 feet) for a total distance of 354.42 feet to an existing steel fence post;

Thence turning and running South 00 deg. 32 min. 25 sec. West for 586.21 feet to an existing iron pin;

Thence turning and running North 89 deg. 28 min. 07 sec. West for 321.54 feet to the centerline of an existing ditch (an existing iron pin being North 89 deg. 28 min. 07 sec. West and 44.00 feet from this point);
