## DESCRIPTION PART LOT 193, 194, 195, 196 AND PART VACATED ALLEYS

Situated in the State of Ohio, County of Richland, Village of Bellville, and being part of Lots 193, 194, 195, 196, and part of vacated Alleys and being more particularly described as follows;

**Commencing** at a 5/8" rebar found marking the southwest corner of Lot 193, also marking the intersection of the north right-of-way line of Durbin Street (60' in width) and the east right-of-way line of Huron Street (66 feet in width);

Thence North 00°18'57" East, 66.0 feet with the east right-of-way line of said Huron Street to the **POINT OF BEGINNING**, passing through a 2" mag nail set in concrete driveway at 65.59 feet;

Thence with the following Four (4) courses:

- 1. North 00°18'57" East, 74.25 feet with the east right-of-way line of said Huron Street to a 2" mag nail set in a concrete driveway;
- 2. North 89°30'30" East, 279.29 feet to a point in the west right-of-way line of School Street (60 feet in width), passing through a 5/8" rebar with cap stamped "Weigler 7747" set at 271.29 feet;
- 3. South 00°26'00" West, 74.25 feet with the west right-of-way line of said School Street to a point being referenced by a 5/8" rebar with cap stamped "Weigler 7747" set South 89°30'30" West, 8.00 feet;
- 4. South 89°30'30" West, 279.14 feet to the point of beginning, containing 20,729.41 square feet, of which 6533.35 square feet are in Part Lot 193, 2185.63 square feet are in Part Lot 194, 4405.06 square feet are in Part Lot 195, 4311.64 square feet are in Part Lot 196 and 3293.73square feet are in vacated Alleys, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on survey file F-1-139 of the Richland County Tax Map Records, and are used to express angles only.
