DESCRIPTION OF 52.504 ACRE PARCEL

Situated in the State of Ohio, County of Richland, Township of Troy, lying in the Northeast and Southeast Quarter of Section Thirty Three (33), Township Twenty (20), Range Nineteen (19), of an original tracts conveyed to Oak Grove Memorial Park, Inc. by deed of record in Official Record Volume 1991, Page 777 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

BEGINNING at a stone found at the Southwest corner of the Northeast Quarter of said Section 33:

thence North 01°26'46" East, with the West line of the Northeast Quarter of said Section 33, a distance of 1625.47 feet to a wood post found at the Southwest corner of a 6.06 acre tract conveyed to J.J. & J.K. Vannatta, Trustees by deed of record in Official Record Volume 2582, Page 803;

thence North 89°29'31" East, with the South line of said 6.06 acre tract and the South line of a tract conveyed to J.S. & J.A. Allred by deed of record in Official Record Volume 1455, Page 115, a distance of 1636.15 feet to an iron pin set at the Northeast corner of a 60.786 acre tract conveyed to said Oak Grove Memorial Park, Inc.;

thence South 01°26'46" West, with the East line of said 60.786 acre tract, a distance of 470.00 feet to an iron pin set;

thence through original tracts conveyed to Oak Grove Memorial Park, Inc. the following four (4) courses and distances:

- 1. South 46°26'46" West, a distance of 840.00 feet to an iron pin set;
- 2. South 01°26'46" West, a distance of 480.00 feet to an iron pin set;
- 3. North 89°01'29" East, a distance of 1000.00 feet to an iron pin set;
- 4. South 60°58'31" East, a distance of 241.50 feet to a railroad spike set in the centerline of S.R. 42, passing by an iron pin set at a distance of 211.50 feet;

thence with said centerline of S.R. 42 the following two (2) courses and distances:

- 1. With a curve turning to the right with an arc length of 55.69 feet, with a radius of 1910.08 feet, with a delta angle of 1°40'13", with a chord bearing of South 51°18'19" West, and a chord length of 55.68 feet to a railroad spike set;
- 2. South 52°08'25" West, a distance of 173.02 feet to a railroad spike set at the Northeast corner of a 5.5 acre tract conveyed to B.L. Meadows & M.J. Anderson, Trustee by deed of record in Official Record Volume 2939, Page 169, referenced by an iron pipe found, North 67°31'44" West, a distance of 38.52 feet;

thence North 67°31'44" West, with the Northeast line of said 5.5 acre tract, a distance of 415.92 feet to a point on the North line of the Southeast Quarter of said Section 33 also being the South line of the Northeast Quarter of said Section 33, referenced by an iron pipe found, North 67°31'44" West, a distance of 1.34 feet;

thence South 89°01'29" West, with the North line of the Southeast Quarter and the South line of the Northeast Quarter of said Section 33 a distance of 1691.23 feet to the POINT OF BEGINNING, containing 52.504 total acres of land, more or less, of which 51.388 acres lies in said Northeast Quarter and 1.116 acres lies in said Southeast Quarter;

Subject, however, to all legal rights-of-ways and/or easements of record.

Iron pins set, where indicated, are iron rebar, five/eights (5/8) inch diameter, thirty (30) inches long with a plastic cap on top stamped "HANNING PS 8568".

The bearings herein are based on Richland County Engineer Survey II-78.
