Beginning for the same at a railroad spike found and accepted as marking the southeast corner of said quarter section and being a point in the centerline of Tucker Road (T.H. 336) and being referenced by an iron pin found on a bearing of South 89 degrees 47 minutes 25 seconds West and at a distance of 30.00 feet, Thence, South 89 degrees 47 minutes 25 seconds West with the south line of said quarter section, passing through said iron pin found, a total distance of 818.24 feet to a point marking the southeast corner of a parcel currently owned by R. & J. Maglott (O.R.V. 2163, Page 825), said point being referenced by an iron pin found on a bearing of North 01 degree 17 minutes 15 seconds West and at a distance of 0.16 feet;
