

DESCRIPTION OF 0.491 ACRE PARCEL

Situated in the State of Ohio, County of Richland, Township of Troy, lying in the Northeast Quarter of Section Thirteen (13), Township Twenty (20), Range Nineteen (19), of an original tract conveyed to S.E. Jeffrey by deed of record in Official Record Volume 296, Page 344 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at the Northwest corner of the Northeast Quarter of said Section 13, referenced by an iron pipe found, North 13°57'16" East, a distance of 36.44 feet;

thence North 79°42'38" East, with the North line of the Northeast Quarter of said Section 13, a distance of 1134.92 feet to a Mag nail set in pavement;

thence South 00°52'28" East, a distance of 7.98 feet to a point in the centerline of Hanley Road (C.H. 139), said point being the POINT OF BEGINNING for the tract herein described, referenced by an iron pipe found, South 00°52'28" East, a distance of 24.35 feet;

thence South 00°52'28" East, with the West line of a 1.15 acre tract conveyed to J. Grogoza by deed of record in Official Record 500, Page 240, a distance of 219.46 feet to a 1/2" rebar found at the Northeast corner of a 0.91 acre tract conveyed to A.M. Sherman, Trustee by deed of record in Official Record Volume 2668, Page 397;

thence South 79°27'59" West, with the North line of said 0.91 acre tract, a distance of 99.00 feet to an iron pin set at the Southeast corner of a 0.5 acre tract conveyed to D.A. Kodger by deed of record in Official Record Volume 2492, Page 346;

thence North 00°52'00" West, with the East line of said 0.5 acre tract, a distance of 219.29 feet to a point in the centerline of said Hanley Road, passing through an iron pin set at a distance of 189.29 feet;

thence North 79°22'02" East, with the centerline of said Hanley Road, a distance of 99.00 feet to the POINT OF BEGINNING, containing 0.491 total acres of land, more or less;

Subject, however, to all legal rights-of-ways and/or easements of record.

Iron pins set, where indicated, are iron rebar, five/eights (5/8) inch diameter, thirty (30) inches long with a plastic cap on top stamped "HANNING PS 8568".

The bearings herein are based on Richland County Engineer Survey JJ-138.
