ROBERT H. OHL 4.975 ACRES Rsp31seb

Situated in the Township of Springfield, County of Richland, State of Ohio and being part of the Southeast quarter of Section 31 and part of the Southwest quarter of Section 32, Township 21, Range 19 and being more fully described as follows:

COMMENCING at the Northeast corner of the Southeast quarter of Section 31 (an existing iron pin being South 86 deg. 10 min. 43 sec. West and 32.33 feet from this point);

Thence running South 00 deg. 37 min. 17 sec. East along the East line of Section 31 for 888.97 feet (an existing iron pin being North 88 deg. 26 min. 14 sec. West and 18.93 feet from this point);

Thence turning and running South 88 deg. 26 min. 14 sec. East for 10.48 feet to the centerline of State Highway 314 and the **PLACE OF BEGINNING** (an existing iron pin being North 88 deg. 26 min. 14 sec. West and 29.41 feet from this point);

Thence turning and running South 01 deg. 50 min. 39 sec. East along said centerline for 200.34 feet;

Thence turning and running North 88 deg. 12 min. 50 sec. West (passing the West line of Section 32 at 14.76 feet and passing a 5/8 inch rebar set at 30.00 feet) for a total distance of 743.92 feet to an existing iron pin;

Thence turning and running North 01 deg. 58 min. 31 sec. West for 399.83 feet to an existing iron pin;

Thence turning and running South 88 deg. 02 min. 37 sec. East for 343.88 feet to an existing iron pin;

Thence turning and running South 01 deg. 58 min. 31 sec. East for 200.00 feet to a 5/8 rebar set;

Thence turning and running South 88 deg. 26 min. 14 sec. East (passing an existing iron pin at 371.06 feet) for a total distance of 400.47 feet to the place of beginning.
