LEGAL DESCRIPTION

PART OF THE SE QUARTER **SECTION 19, T-23 N, R-18 W BLOOMINGGROVE TWP.** RICHLAND COUNTY, OHIO

March 17, 2025

Situated in the Township of Bloominggrove, County of Richland, State of Ohio and being a part of the Southeast Quarter Section 19, Township 23-North, Range 18-West, being a parcel conveyed to Eugene N. and Elva N. Shirk by official record volume 2630, page 93, being more particularly described as follows:

Commencing at a railroad spike found and accepted as marking the southwest corner of said Quarter and being on the centerline of Lamp Road-(T.H. 225)(60' R/W)

Thence, North 89 degrees 00 minutes 02 seconds East, 219.91 feet along the south line of said Quarter, said centerline of Lamp Road to a 2" Magnail spike set being the **Place of Beginning** of the parcel herein described;

Thence, the following **FOUR** Courses:

- 1. North 01 degree 46 minutes 32 seconds West, 259.38 feet traversing aforementioned Shirk parcel to a point, passing through iron pins set for reference at 20.00 feet and 239.38 feet;
- 2. North 67 degrees 20 minutes 33 seconds East, 53.52 feet traversing said Shirk parcel to a point on the west line of a parcel conveyed to Karissa J. and Ronald L. Gibson by official record volume 1828, page 157;
- 3. South 01 degree 46 minutes 32 seconds East, 279.13 feet along said west line of Gibson parcel to a 2" Magnail spike set on the south line of the aforementioned Quarter, the aforementioned centerline of Lamp Road, passing through an iron pin set for reference at 20.00 feet and an iron pin found for reference at 258.77 feet;
- 4. South 89 degrees 00 minutes 02 seconds West, 50.01 feet along a south line of said Quarter, said centerline of Lamp Road to the **Place of Beginning**, containing 0.3091 of an acre (13,464.21 Sq. Ft.), more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.

Bearings are based on an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with cap stamped "Ramsey S-8396"

Grantees, their heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument does not constitute a principal building site and will not be conveyed by said grantees, heirs and assigns independent and separate from any adjoining or contiguous parcel.
