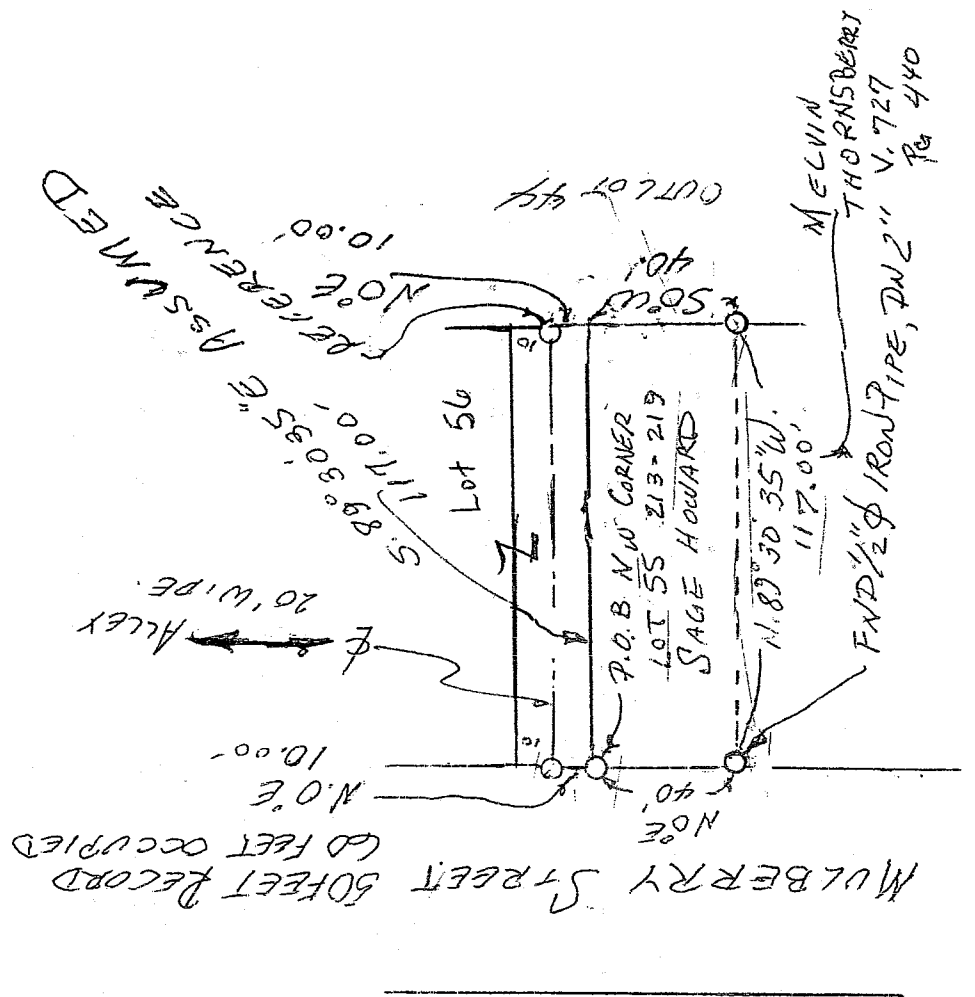
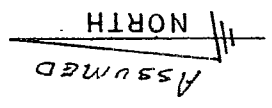

Legal Description

BEING A PARCEL, WHICH HAS ITS ORIGINS IN A PARCEL, CONVEYED IN OFFICIAL RECORD VOLUME 213 AT PAGE 0219 WHICH IS SITUATED IN THE STATE OF OHIO, COUNTY OF RICHLAND, TOWNSHIP OF PLYMOUTH, VILLAGE OF PLYMOUTH [V.5 PG. 14] AND BEING THE NORTH 40 FEET OF INLOT 55 OF SAID VILLAGE, TOWNSHIP 22, RANGE 19 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN 0.8 INCH OUTSIDE DIAMETER IRON PIPE SET WITH CAP 5647 AT THE NORTHWEST CORNER OF SAID LOT 55.
