

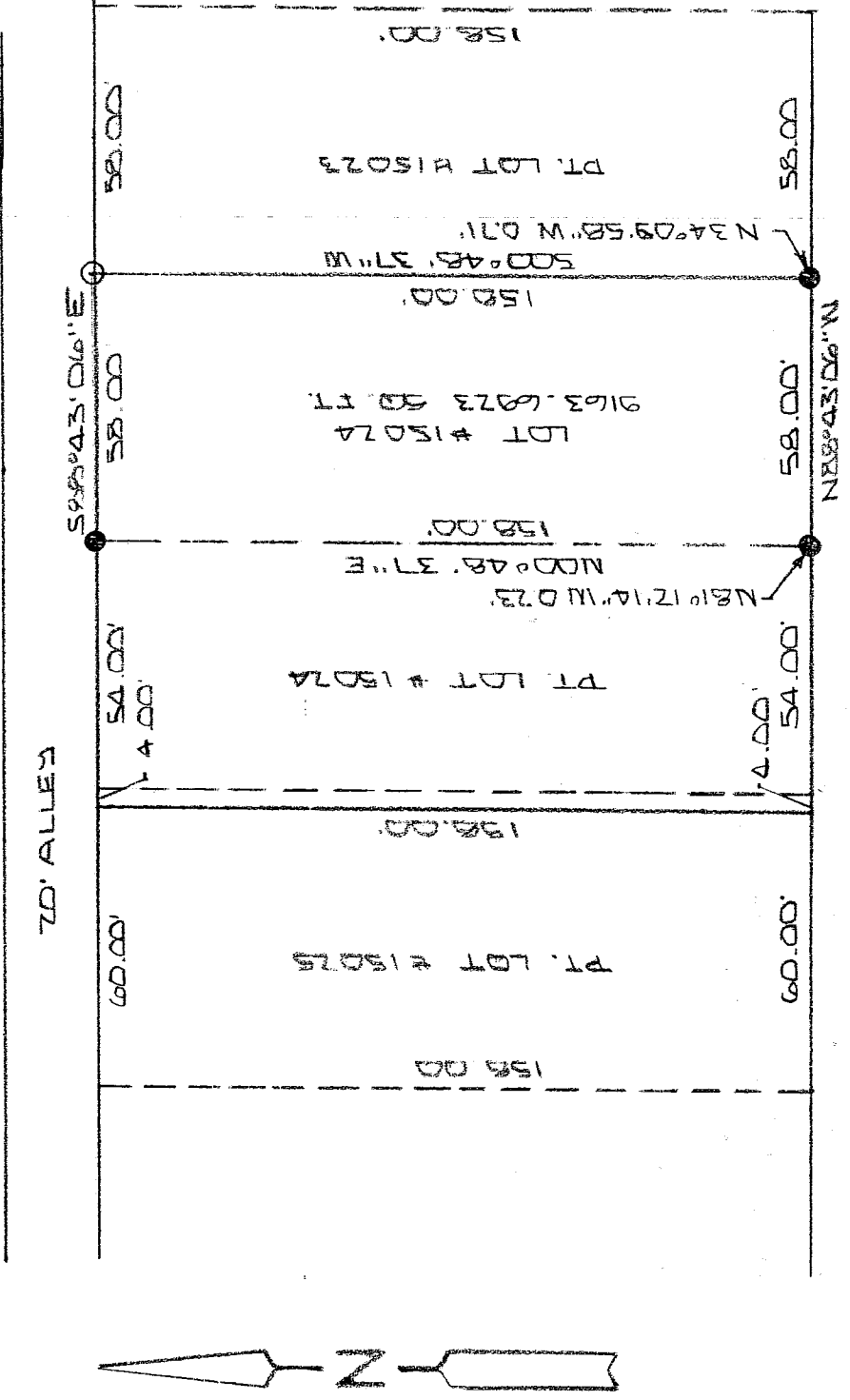

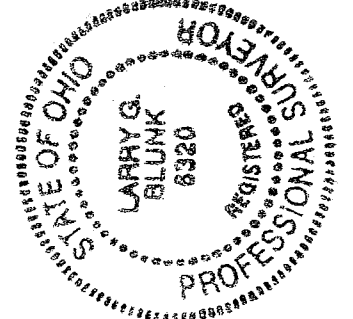

Located in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot Number 15024 as recorded in Volume 20, Page 25 of the Richland County Plat Records and more particularly described as follows:

Beginning at an iron pin set in the Northeast Corner of Lot Number 15024.

Thence S 00 degrees 48' 37" W along the east line of Lot Number 15024 a distance of 158.00 feet to the Southeast Corner of Lot Number 15024, referenced by an iron pin found N 34 degrees 09' 58" W - 0.71 feet.

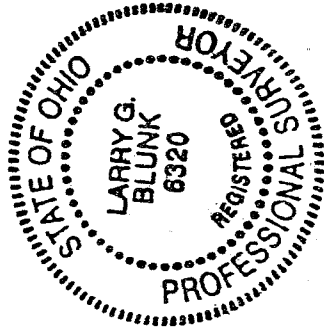
Thence N 88 degrees 43' 06" W along the south line of Lot Number 15024 a distance of 58.00 feet, referenced by an iron pin found N 81 degrees 12' 14" W - 0.23 feet.

Thence N 00 degrees 48' 37" E a distance of 158.00 feet to an iron pin found on the north line of Lot Number 15024.

Thence S 88 degrees 43' 06" E along the north line of Lot Number 15024 a distance of 58.00 feet to the place of beginning and containing 9163.6923 square feet but subject to all legal highways also all easements of record.

Basis of Bearings: Bearings are to an assumed azimuth and are used to denote angles only.
