- S 18° 40' 36" W, 61.45 feet to an iron pin set in the north line of Lot No. 3055 of Woodland Park Phase 5 as recorded in plat volume 29, page 28;
- N 88° 16' 15" W, 52.55 feet along said north line of said Lot No. 3055 to the place of beginning and containing 0.072 acre, more or less, and subject of all legal highways and easements of record.
