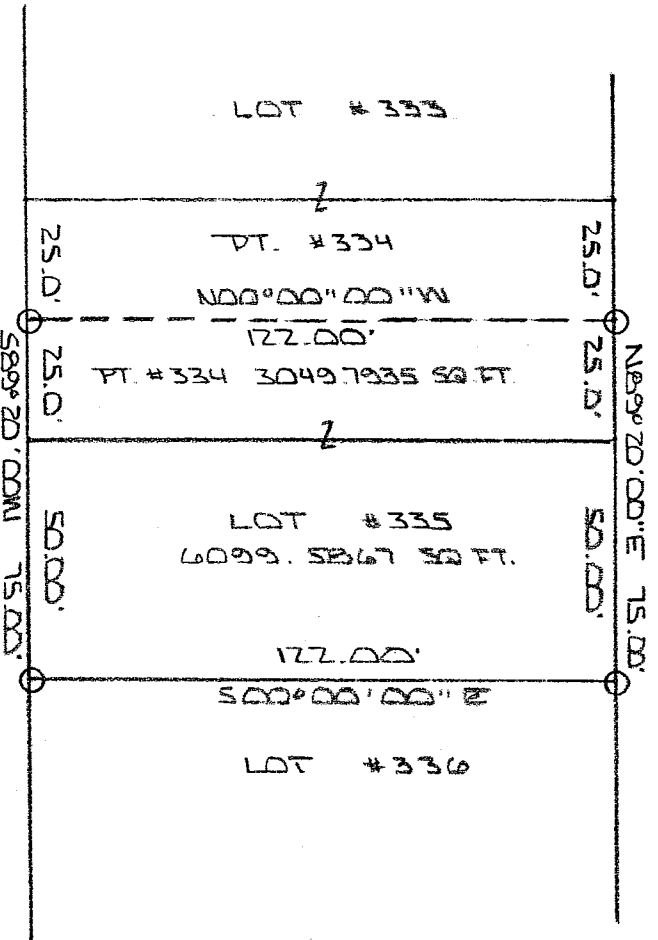


# PLAT OF SURVEY FOR MARARA A. SLOAN

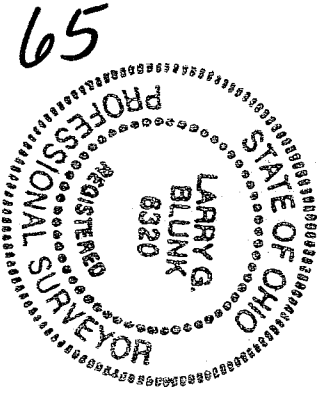

Located in the Township of Madison, County of Richland, State of Ohio and being Lot Number 335 and a part of Lot Number 334 of Lincoln Fields Allotment as recorded in Volume 15, Page 20 of the Richland County Plat Records and more particularly described as follows:

Beginning at an iron pin set in the Northeast Corner of Lot Number 335.

Thence S 00 degrees 00' 00" E along the east line of Lot Number 335 a distance of 122.00 feet to an iron pin set in the Southeast Corner of Lot Number 335.

Thence S 89 degrees 20' 00" W along the south line of Lot Numbers 335 and 334 a distance of 75.00 feet to an iron pin set.

Thence N 00 degrees 00' 00" W a distance of 122.00 feet to an iron pin set on the north line of Lot Number 334.

Thence N 89 degrees 20' 00" E along the north line of Lot Numbers 334 and 335 a distance of 75.00 feet to the place of beginning and containing 9149.3802 square feet in all of which 3049.7935 square feet are in a part of Lot Number 334 and 6099.5867 square feet are in Lot Number 335 but subject to all legal highways also all easements of record.
